1 EXPRESSIONS OF INTEREST

Expressions of Interest are invited by Yarra Holdings Limited for 140,000 verified Voluntary Carbon Credits (VVCC®) sourced from its extremely rare and unique Pre-1990 New Zealand indigenous forest located at 115 Fairhill Road, Greymouth 7805, in the West Coast of the South Island of New Zealand.

These credits have been independently verified by New Zealand-based GreenXperts Limited under its Voluntary Vintage Carbon Credit® Scheme.

The VVCC® Scheme uses the "Avoided Deforestation" approach to generate authentic voluntary credits. Verified New Zealand VVCC® forests have no absolute legal protection from deforestation and are majority Pre-1990 New Zealand indigenous forest. Voluntary credits are issued with a 100-year preservation instrument on land titles. On-site monitoring and spot monitoring is compulsory. Verification, Validation, and Monitoring Reports are publicly available.

Forest carbon content assessment is completed using a state-of-the-art scientific method based on real, physical assessment of the carbon reservoir present in the heritage trees. High resolution drone and satellite 3D imagery of the forest is supported by a carbon plot ground truthing exercise. The Al-assisted carbon assay is validated by high-resolution manual imagery analysis. Carbon content found is consistent with previous New Zealand Government-sponsored research into carbon reservoirs in Pre-1990 New Zealand indigenous forest.

The Verification Report has been independently validated by acknowledged world climate authority, Dr Mona Wells, Climate Director, from the Meadows Centre for Water and the Environment, Texas State University.

Buyers can be fully assured that the forest exists, it is real, that the voluntary credits issued from it are authentic, and that they will remain preserved for at least 100 years. Visits to the forest site are welcome by arrangement.

This is the first issue of VVCC® from Fairhill Forest. As the forest is still young (about 100 years), it is actively growing and storing carbon, so future annual credit issues may occur.
